## Construction Notice Airport Road Reconstruction

**Where:** Airport Rd – Grand River Ave to Herbison Rd

**When:**

Phase 1 – Clark Rd to Herbison Rd – September 9<sup>th</sup> to October 18<sup>th</sup>, 2025

Phase 2 – Grand River Ave to Clark Rd – March to August 2026

**What is being done:** The Clinton County Road Commission (CCRC) will be reconstructing Airport Road, including traffic signal upgrades at Clark and Stoll intersections, sight distance improvements at Mesa Verde Blvd, widened paved shoulders and roadside drainage improvements throughout the project.

**Why is this being done:** The improvements are necessary to ensure safe, reliable, and efficient travel for all roadway users in the Airport Rd corridor. The existing roadway is deteriorated and does not meet current design guidelines based on current and future traffic volumes.

**How will this impact the community:**

Motorists should anticipate traffic congestion and delays within the project vicinity during construction. Local traffic with a destination within the construction limits will be maintained, however it may be periodically restricted due to construction activities. Residential access will vary depending on the timing and location as the work progresses throughout the project. Please plan your travel routes and times carefully to account for probable traffic delays.

Your patience with the road construction project will be greatly appreciated, CCRC understands the work is disruptive to the community, businesses, schools, property owners, and township services. However, the disruption is temporary, and every effort will be made to construct the project in an efficient manner to reduce impacts to the community.

**Anticipated work areas and dates:**

**Phase 1: Airport Rd – Clark to Herbison – September 9<sup>th</sup> to October 18<sup>th</sup>, 2025**

Airport Rd will be closed to through traffic between Clark Rd and Herbison Rd. Clark and Herbison intersections remain open. Posted detour route Clark to Schavey to Herbison. Work scope includes mill & fill asphalt resurfacing, shoulder widening and hill cut.

Road will be fully closed between Mesa Verde Blvd and the entrance to the Conquest Fitness complex, no vehicle access through this area due to excavation work.

Local access for residents & businesses on Mesa Verde Blvd and Sedona Pkwy will be maintained from the south (Clark Rd) only. Vehicles will not be able to enter or leave Mesa Verde Blvd to the north (Herbison Rd)

Local business access to the Conquest Fitness complex will be maintained from the north (Herbison Rd) only. Vehicles will not be able to enter or leave to the south (Clark Rd).

Airport Rd and I-69 remain open south of Clark Rd during Phase 1

## Anticipated work areas and dates: (continued)

### **Phase 2: Airport Rd – Grand River Ave to Clark Rd – March to August, 2026**

Start and end dates to be determined, additional notices and detour maps will be distributed by CCRC prior to work starting in 2026.

Airport Rd will be closed to through traffic between Grand River Ave and Clark Rd. Local access for residents within the work limits will be maintained. The Grand River Ave intersection will remain open. Port Lansing Rd, State Rd, Stoll Rd, Earnest Way, and Clark Rd intersections will be closed intermittently with local access only.

One-way traffic will be maintained between I-69 and Clark Rd during construction, with intermittent ramp closures.

An additional work phase may be added for traffic signal prep work prior to March 2026 start, traffic to be maintained with temp lane & shoulder closures, no detours during this time.

## Accommodations:

CCRC will coordinate with local schools if any bus routes or stops need to be temporarily adjusted during construction, residents will be notified directly in advance of any changes. USPS mail service will be maintained throughout the project, mailbox locations may be temporarily relocated to accommodate USPS driver access. Trash services will be maintained throughout the project, CCRC and the contractor will coordinate with local providers to maintain access. CCRC and the contractor will coordinate directly with police and fire to ensure emergency services are maintained.

Driveways may be inaccessible for limited periods during construction, but accommodations will be made for residents to park within the ROW as close to their property as possible. Please contact project staff if you need special accommodation or have other accessibility concerns during construction.


Any items within the road right-of-way, in the construction limits, including trees, landscaping, fences, underground dog fences, irrigation systems, etc., are subject to removal. CCRC is requesting residents relocate any such appurtenances before construction begins, please contact project staff if you have questions on items that may be impacted on your property. CCRC is not responsible for the salvage or replacement of these items.
